Katherine also acted for members of the public in investigations by the IPCC and civil actions against the Police for damages for wrongful arrest and false imprisonment.

Area of Practice

Katherine has assisted in high-profile cases, including the appeal of Myra Hindley to the House of Lords (as it then was); the successful appeals of Robert Thompson and Jon Venables to the European Court of Human Rights, against



the legality of the Home Secretary's role in setting sentencing tariffs and the successful appeal by Winston Silcott against his wrongful conviction for the murder of PC Blakelock during the 1985 Broadwater Farm riots.
